- : For tables and seating orders specified with Quick-Ship fabrics, manufacturing begins upon approval of purchase order.
- : For seating orders specified with COM, products will be available to ship within ten (10) business days after receipt of fabric.
- : Quick-Ship purchase orders should be designated as such and must be placed separately from standard lead-time purchase orders. No split purchase orders allowed.
